### Annual Primary Membership Form

#### Terms & Condition of Admissions as Associate Member :

- 3 The federation reserves the right to refuse any application for membership at its sole discretion without assigning any reason.
- 4 Membership of the ITCF is valid for one year from the date of joining or renewing
- 5 Membership Cards are personal to the member and are not transferable
- 6 Loss of membership card should be reported to the ITCF immediately. Duplicate card will be issued after receipt of administrative charges of Rs. 150/-
- 7 If the remittance tendered by way of Cheque/DD is not honoured or in any other way refused by bankers, the member shall be liable to pay administrative charge of Rs.100/- (or such other amount as the ITCF may inform the members from time to time) and any bank or other similar charges incurred by the ITCF as a result, and such membership shall be immediately suspended till such realisation.
